
Subject: You're Officially A Member of the Reveille Grounds Ecosystem!

Reveille Grounds Facility Use Agreement

Reveille Grounds is committed to fostering a community that thrives on shared stewardship, collective impact, and mutual benefit. This Facility Use Agreement outlines the expectations and responsibilities for all members and guests to ensure that it remains a welcoming and well-maintained environment for all. This mission - this space - belongs to us all.

Agreement Terms

- 1. Shared Stewardship
 - All users of the space are expected to leave the space better than they found it.
 - Responsibilities include:
 - Resetting tables and chairs to their original location unless otherwise requested ahead of time.
 - Returning AV equipment to its designated storage location.
 - Making a plan for any leftover food.
 - Ensuring that no dirty dishes or utensils are left in/around the sink and that all utilized kitchen items are put away.
 - All trash in the conference rooms, bathrooms, kitchen, and coffee bar area must be removed from the area and deposited in the campus dumpsters before departing for meetings of more than 10 people.

2. Responsibility for Guests

- Members and bookers are responsible for the actions and behavior of all coworkers, attendees, and invited guests within Reveille's physical space, on campus, and within the surrounding property.
- Any damage caused during the booking or use period must be reported immediately and may result in repair fees.
- Unless previous permission has been obtained, occupancy outside of scheduled events and Core Hours is restricted to registered members ONLY.

3. Cleanliness and Orderliness

- Spaces used must be reset to their original configuration unless otherwise agreed upon in advance.
- Custodial services are included in your fees, but floors should be swept and counters wiped if necessary, and any utilized spaces should generally be left clean and in working order.

4. Spirit of Collective Impact

- Users are encouraged to align their activities with the values of collaboration and mutual benefit that define Reveille Grounds, including remaining committed to an environment of respect, inclusivity, and shared purpose.
- When possible, events and activations should make every effort to incorporate additional relevant partners and member organizations for marketing opportunities and mission alignment.

5. Facility-Specific Guidelines

- There is to be NO smoking within our facility or outside on the catwalk.
- Use of certain spaces may have additional guidelines, which will be provided at the time of booking.

6. Liability and Insurance

- Users agree to indemnify and hold harmless Reveille Grounds from any claims arising out of their use of the facility.
- Proof of liability insurance may be required for certain bookings and/or Memberships.

7. Termination of Use

• Reveille Grounds reserves the right to terminate a booking or membership without refund for failure to adhere to Reveille's core values and the terms of this agreement.

8. Acknowledgment

- By signing these agreements, users acknowledge their understanding and acceptance of these terms and commit to upholding the principles of stewardship and collective impact.
- This agreement ensures that all members and users contribute to the sustainability and success of Reveille Grounds as a community hub. Thank you for your commitment to shared stewardship and collective impact.
